# 23.028 To receive and confirm the minutes of the meeting held on 10<sup>th</sup> May 2023

The minutes of the meeting held 10<sup>th</sup> May 2023 were confirmed as a correct record and signed.

## 23.029 To receive the police reports

# 23.030 To receive news from the Unitary Authority Councillors.

Councillor Stocks reported that: -

- there had been a change of political control at Cheshire West and Chester Council
- a new highways contractor had been appointed and the changeover may impact on the timing of works.
- there was a potential project at the Swan Green Play Area to enhance provision for children with disabilities.
- HS2 is likely to cause traffic disruption to the A556 and this will have knock on effects on Lower Peover.
- the dispute between Cheshire West and Chester council and Harvey Holmes regarding the development at Swan Green remains unresolved.
- financial support to refurbish the finger post a Crown Lane might be available this year.
- the Police and Crime Commissioner is trialling mobile average speed cameras in two parishes and, depending upon the outcome, these

may become available in future.

Councillor Stocks agreed to make inquiries to ascertain whether Cheshire West and Chester council were undertaking any work regarding the quiet lanes initiative.

the Parish Council thanks Councillor Stocks for his support over the last year particularly in securing grants projects in the village relating to traffic calming and the refurbishment of the fingerpost at the Hulme Lane junction with Back Lane.

As a result the parish council would now consider what further measures could be undertaken to reduce speeds particularly when entering the village
